

Personal Data Processing Privacy Policy

This Privacy Policy is designed to describe how the www.ksportatschool.eu (hereafter the "Site") website is managed regarding the processing of the personal data of its visitors.

It is a general Privacy Policy provided in compliance with Article 13 of Regulation (EU) 2016/679 governing the (i) protection of natural persons concerning the processing of their personal data, and (ii) the free circulation of such data (hereinafter the "Regulation") to all the users who access and/or register themselves and, more generally, interact with the services delivered through the Site of the Italian Judo Wrestling Karate Martial Arts Federation (hereafter also referred to as FIJLKAM or "Controller" or the "Federation"), having its registered office in Via dei Sandolini, 79 - 00122 Ostia Lido.

In this Privacy we will describe the purposes for which and the methods whereby the Controller collects and processes your personal data, the categories of data that are subject to processing, the rights of the data subjects and how these rights can be exercised. Your personal data will be processed using suitable paper-based, electronic and/or computer telecommunications tools, in strict accordance with the aforesaid purposes and, in any event, in such a way as to guarantee the security and confidentiality of your data.

This Privacy Policy applies solely to this Site. As a result, FIJLKAM will in no way bear any responsibility for any other websites that may be visited using the links available on the Site. This Policy Privacy, however, encompasses other Internet domains that replicate the Site, if any.

By using this Site, the users accept this Privacy Policy and are, therefore, encouraged to read it before they provide any kind of personal information.

Categories of personal data

a. Navigation data

Information systems and software procedures underlying the running of this website will, during their normal operations, collect some personal data, the transmission of which is considered as implied in the use of Internet communication protocols.

These data are not collected in order to be associated with identified data subjects; however, given their nature they may, by processing and associating them with data held by third parties, allow users to be identified.

This type of data includes the IP addresses and domain names of the computers used by the users to access the website, addresses in URI (Uniform Resource Identifier) notation of the resources requested, time of request, method used to submit the request to the server, size of the file received in response, numerical code representing the status of the response provided by the server (successful, error, etc.) and other metrics related to the user's operating system and IT environment.

These data are used for the sole purpose of gathering anonymous statistical data regarding the use of the site and to check its proper running and are deleted immediately after



processing. These data may be used to investigate and establish liability in the event of possible cybercrimes against the site.

b. Data provided by the user on a voluntary basis

Without prejudice to the foregoing regarding navigation data, FIJLKAM will, through the Site, collect any personal data provided by the user through the Site to access certain services (e.g. through the restricted area) or to submit requests by email. For example, the Site will collect the first name and last name, street address, date of birth, email address, user name, password and any other information, including personal information, provided directly by the data subject.

While operating the Site, the Controller will not acquire any sensitive data or at any rate data belonging to the special categories under Article 9 of Regulation (EU) 2016/679 or data pertaining to criminal convictions or offences.

c. Data collected when services are delivered

The Controller may also collect some personal data concerning the registered user when he/she receives the services provided by FIJLKAM through the Site.

The aforesaid personal data will be processed by the Controller for the sole purposes of, and to the extent as set forth in, the following paragraph.

Purposes of processing and legal basis

a. For the delivery of the required services

The data referred to under (b) and (c) above will be processed by the Controller to allow you to register with the Site and benefit from the services specifically related thereto. The data will therefore be processed to establish the legal relationship with the Controller. Providing such data is deemed as necessary.

b. To comply with law requirements

The data under (b) and (c) above will be processed by the Controller to comply with the obligations laid down by law and related regulations, the Federation's By-laws and Regulations, EU regulations as well as provisions issued by Authorities empowered to do so by law.

c. For the purpose of reporting events

FIJLKAM may process your data to report events, including on a national scale, that involve the Federation with a view to promoting sports endeavours and for institutional purposes only. To pursuit such purposes, FIJLKAM may process the data as under (b) and (c) above.

Categories of individuals to whom personal data may be disclosed and purposes of disclosure

The Controller may, for the same purposes, also disclose some of your personal data to third parties who will process your personal data in their capacity as Data Processors. The list of Data Processors may be obtained from the Controller at any time.

The list of Data Processors may be obtained from the Controller by writing an email to segreteria.federale@fijlkam.it.

Period of retention of the data and duration of processing

Your data will be retained throughout the contractual relationship and/or registration with the Controller, upon termination of which, for any reason whatsoever, your data will be retained (i) for such a period of time as may be strictly necessary, (ii) to ensure the protection of the Controller's rights and (iii) to comply with law obligations (such period not exceeding 10 years as of the expiry of the contract and/or last registration effects). Navigation data will be retained for a period of time not exceeding 12 months.

Data Subject Rights

Please be informed that according to the applicable regulations you are entitled to the following rights: seek and obtain information as to whether your data are held by the Controller and access such data; with regard to data processed using automated systems, seek and obtain the data concerning you held by the Controller in a structured, commonly used and machine-readable format; seek and obtain amendment/rectification of your personal data if you believe them to be inaccurate or incomplete; seek and obtain erasure — and/or restriction of processing — of your personal data if they relate to data or information that are not necessary, or no longer necessary, for the aforesaid purposes, hence once the retention period stated in the previous paragraph has expired.

In particular, these rights are recognised under Regulation (EU) 2016/679 (GDPR Articles 15 - "Right of access by the data subject", 16 - "Right to rectification", 17 - "Right to erasure", 18 - "Right to restriction of processing", 19 - "Notification obligation regarding rectification or erasure of personal data or restriction of processing", 20 - "Right to data portability" to the extent and under the conditions as set forth by Article 12 of the Regulation.
